## **1. INTRODUCTION**

The Department of Defense (DOD) of the United States of America and the Federal Ministry of Defense (MOD) of the Federal Republic of Germany, herein after referred to as the "Parties", entered into an Agreement Concerning Collaborative Logistics Support Measures for the Nuclear, Biological, Chemical Reconnaissance System on April 18, 1995.

## **2. AMENDMENT AND EXTENSION**

2.1. In accordance with Article XVII (AMENDMENT, TERMINATION, ENTRY INTO FORCE, AND DURATION) the Parties hereby mutually agree to the following:

2.1.1. Extend the Agreement Concerning Collaborative Logistics Support Measures for the Nuclear, Biological, Chemical Reconnaissance System to April 18, 2020.

2.1.2. Change Article IV MANAGEMENT (Organization and Responsibility), paragraph 4.2 from "United States Army Chemical, Biological, Defense Command (CBDCOM)" to "Joint Project Manager for Nuclear, Biological, Chemical Contamination Avoidance."

2.1.3. Replace Article IV MANAGEMENT (Organization and Responsibility), paragraph 4.8., with the following:

Contamination Avoidance

German PM

2.1.4. Change Article V COST AND SETTLEMENT OF ACCOUNTS, paragraph 5.2., line 5 from "DM 100,000.00" to "52,000 Euros"

2.1.5. Change Article V COST AND SETTLEMENT OF ACCOUNTS, paragraph 5.7.1., line 2 from "DM 1,000" to "500 Euros"

2.2. All other provisions of this Agreement remain unchanged.

**3. EFFECTIVE DATE**

This AMENDMENT ONE shall enter into force on the date of the last signature below with an effective date of 18 April 2005.


