NOTE BY THE DEPARTMENT OF STATE

Pursuant to Public Law 89—497, approved July 8, 1966  
(80 Stat. 271; 1 U.S.C. 113)—

“ . . .the Treaties and Other International Acts Series issued under the authority of the Secretary of State shall be competent evidence . . . of the treaties, international agreements other than treaties, and proclamations by the President of such treaties and international agreements other than treaties, as the case may be, therein contained, in all the courts of law and equity and of maritime jurisdiction, and in all the tribunals and public offices of the United States, and of the several States, without any further proof or authentication thereof.”

## NOTE VERBAL

The Embassy of the Republic of Hungary presents its compliments to the Honourable Department of State of the United States of America and has the honour to refer to the Air Transport Agreement between the Government of the United States of America and the Government of the Republic of Hungary signed on July 12, 1989.

On behalf of the Republic of Hungary, this Diplomatic Mission has the honour to propose that the Annex to the 1989 Air Transport Agreement, which will expire on July 12, 2007, be extended until the Air Transport Agreement between the United States of America and the European Community signed in Washington D.C. on April 30, 2007 will commence being applied from March 30, 2008 as agreed by the contracting parties in Article 25 of the same Agreement.

If the foregoing proposal is acceptable to the Government of the United States of America, the Embassy of the Republic of Hungary has the further honour to propose that the present Note and the affirmative reply of the Department of State shall constitute an Agreement between the two Governments which shall enter into force on the date of the replying Note. The Embassy would be grateful to receive a response at the Department's of State earliest convenience.

The Embassy of the Republic of Hungary avails itself of this opportunity to renew to the Honourable Department of State of the United States of America the assurances of its highest consideration and esteem.

The Department of State refers the Embassy of the Republic of Hungary to the Embassy's Note Verbal, dated June 25, 2007, which proposes, on behalf of the Republic of Hungary, to extend until March 30, 2008, the annex to the air transport agreement between the United States of America and the Republic of Hungary, signed at Budapest July 12, 1989 ("the Agreement").

On behalf of the United States of America, the Department of State declines to extend the annex until March 30, 2008, and proposes instead that the annex be extended indefinitely.

If this counter-proposal is acceptable to the Government of the Republic of Hungary, the Department of State further proposes that this note and the Embassy's affirmative note in reply shall constitute an agreement between the United States of America and the Republic of Hungary to extend indefinitely the annex to the Agreement which would enter into force on the date of the Embassy's note in reply, with effect from July 12, 2007.


