Most of the maps were duplicated by rapid and inexpensive processes, such as photostat, vandyke, or ozalid, but some were printed by photolithography. Most of the texts for the reports are typed copies (ribbon or carbon copy), but some have been mimeographed. A few of these reports and maps were made available in limited quantities for distribution, as indicated in the list, and these may be obtained as long as the supply lasts.

The reports and maps of the Conservation Division concern the production history, the geology, or the topography of federally owned or controlled lands with regard to water power, oil, and gas; these cover areas studied and mapped by geologists and engineers in 5 States, Alaska, and Chile, and include a revised estimate of the water-power resources of the world.

The reports and maps of the Geologic Division contain results of work accomplished by Survey geologists in 22 States, Alaska, and Panama. These maps and reports are released in preliminary form in order

to make information immediately available to property owners and mine operators concerned with exploration for and production of minerals, fuels, and construction materials.

The reports of the Water Resources Division contain information on streamflow, ground water, quality of water, and related geology and hydrology, in the United States, Alaska, the Virgin Islands, Puerto Rico, and Chile.

A general index follows, in which the reader is referred to a report by the name of the author or the first-named of a group of authors; a key number, as guide to the specific report of an author; and a key letter, as guide to the division heading under which the report is listed.
