Bernie O'Neill met recently with Dr. Mancuso. They discussed, among other subjects, data on railroad shopworkers who used asbestos products in the repair of locomotives. We want to pursue this further with Dr. Mancuso because the data and his ideas for their analyses are interesting.

In view of our interest in Dr. Mancuso's research and his assistance to us in reviewing scientific materials, we are requesting authorization for \$16,500 for consultation work. This would cover the period to November 1, 1981. We recommend that it be paid from Special Account #4. During this time, we will be evaluating the research Dr. Mancuso is interested in undertaking.
